Dear George:

It was a pleasure speaking with you on Friday, September 12th. Thank you for your time and thoughtful consideration.

Thank you, as well, for agreeing to serve as a Sponsor for my admission to the Supreme Court Bar. As we discussed, I am seeking admission at this time so that I may timely file an amicus brief on or before **October 9, 2025**, opposing certiorari in the matter of Alex Emric Jones, et al., Petitioners v. Erica Lafferty, et al., Case No. 25-268. You stated that you anticipate Attorney [REDACTED] will also agree to serve as a co-Sponsor and, therefore, asked me to copy him on this email, which I have done.

I am attaching a copy of the **Application for Admission to Practice** before the Supreme Court that I completed and signed on September 14th. As you will note, in completing the Application, I filled in my name in the Applicant's box under the **Admission on Written Motion** section. I very much appreciate your wonderful offer for me to come to Washington so that you may move for my admission in open Court on October 7th or 8th; but, upon further reflection and review of all that I must get accomplished prior to this first filing in the Supreme Court, and in view of the possibility of unforeseen circumstances that could cause last-minute delays, I must regretfully decline your kind offer for an in-person, open-court motion and admission on October 7th or 8th and just a day or two before the **October 9th filing deadline**. This is a public advocacy for me, and the public's interest in **ensuring a timely filing** of the amicus brief outweighs my personal interest and preference to travel to Washington to meet with you for open-court admission proceedings.

Thus, pursuant to an **Admission on Written Motion** course of action, and if it's agreeable to both you and [REDACTED], this week, I will overnight my original Application (with wet signature), the \$200 application fee, and my original Certificate of Good Standing (which I ordered from the Ohio Supreme Court on September 11th and anticipate receiving by mail this week) to [REDACTED] along with additional, pre-paid and pre-addressed overnight envelopes for subsequent delivery to George and, finally, to the Supreme Court Clerk's Admissions Office.

Please let me know if the plan I've outlined meets with your respective approvals. If so, I will out send the overnight application package for initial and subsequent delivery to your respective offices (and, finally, the Clerk) at:
