It was a pleasure speaking with you today. Thank you for your time and kind assistance.

Per your request, I am attaching a copy of the complete application package I am submitting for admission to the Supreme Court Bar and which is scheduled for delivery to the Admissions Office tomorrow, **October 9th**, by UPS Next Day Air, coming directly from the office of my sponsors at Wilenchik & Bartness, in Phoenix.

As we discussed, **October 9th** is the deadline for the filing of my *amicus* brief in *Alex Emric Jones, et al., Petitioners v.
